Registration Process for PUC Service List

To sign up for the service lists for DE 21-143, DE 21-136, and DE 21-141 directly, entities should:

- 1. Submit a request via email to ClerksOffice@PUC.NH.gov
- 2. Reference the docket numbers (DE 21-136, DE 21-141 and DE 21-143) in the subject line of the email.
- 3. Attach a dated letter, in PDF form, addressed to the Chair of the PUC.¹ The letter should include the name and address of the person submitting the document and the party or parties on whose behalf it is submitted, if any.²

Additionally, be advised that:

- PUC review of electric aggregation plans are not adjudicative proceedings (or "contested cases") pursuant to RSA 53-E:7, II. As such, filings are not required to be sent to all parties on the service list. For reference, current service lists are accessible online.³
- The PUC maintains in effect a COVID-19 related rule waiver that suspends the usual requirement for non-adjudicative proceedings of submitting three (3) paper copies of filings in favor of electronic filings only.⁴
