Update on CPA Administrative Rules

Be advised that the New Hampshire Public Utilities Commission (PUC) has docketed the two petitions for rulemaking submitted by (1) CPCNH on behalf of a coalition of stakeholders and (2) the New Hampshire Department of Energy. The respective docket numbers are DRM 21-142 and DRM 21-135, which are available online below:

Additionally, be advised that the PUC has scheduled a public meeting to discuss and receive public comment on both CPCNH's petition and that of the Department of Energy at 2 PM EST on January 5, 2022.

Registration Process for PUC Service List

To sign up for the service lists for DRM 21-142 and DRM 21-135 directly, entities should:

- 1. Submit a request via email to ClerksOffice@PUC.NH.gov
- 2. Reference the docket numbers (DRM 21-142 and DRM 21-135) in the subject line of the email.
- 3. Attach a dated letter, in PDF form, addressed to the Chair of the PUC.¹ Note that the letter should include the name and address of the person submitting the document and the party or parties on whose behalf it is submitted, if any.²

Additionally, be advised that:

- The PUC has referenced docket **DRM** 21-142 in the public meeting notice as "**DE** 21-142" in the online Docket Book.
 - "DE" stands for Docket Electric whereas "DRM" stands for Docket Rule Making.
 - This appears to be an inconsequential discrepancy.
- Rulemaking is a legislative function delegated to the executive branch, and not an adjudicative proceeding.
 - As such, filings are not required to be sent to all parties on the service list.
 - For reference, current service lists are accessible online.³.
- The PUC maintains in effect a COVID-19 related rule waiver that suspends the usual requirement for non-adjudicative proceedings of submitting three (3) paper copies of filings in favor of electronic filings only.⁴
